PROJECT: The Navajo Nation Capital Projects Management Department (NNCPMD) of the Division of Community Development hereby issues this COST PROPOSAL for a Master Growth Plan for the community of Navajo, New Mexico located within Red Lake #18 Chapter. The project site is located 19 miles North of Window Rock, Arizona on Indian Route 12.

This Project shall consist of Phase One of the Master Growth Plan. The Scope of Work will include: Collection of existing information and data relative to housing, transportation, parks, economic development, including facilitation of community and stakeholder input work sessions, analysis of existing land uses and availability and community needs, etc. for the 960-acre site that is Navajo, New Mexico.

PROJECT SITE VISIT: October 16, 2018 at 10AM (MDT). Interested Parties may obtain a COST PROPOSAL Package at the site visit located in Navajo, New Mexico. All interested contractors are invited.

CLOSING DATE FOR RECEIPT OF PROPOSALS: November 2, 2018 at 3PM (MDT).

BID OPENING: November 5, 2018 Closed to the Public

Proposals must be submitted in two parts: (1) a sealed envelope containing the specific Planning Services/Architectural & Engineering proposed for this project; (2) a sealed envelope containing the proposed fee or fee schedule for P/A&E services for this Project. All proposals must be received by Elmer Johnson, NNCPMD, by the Closing Date shown above at NNCPMD office at Administration Building Number 2, 2<sup>ND</sup> floor, Window Rock Boulevard, Window Rock, Arizona. Opening of proposals and selection will be made in accordance with the Navajo Business Opportunity Act. E-MAILED OR FAXED PROPOSALS WILL NOT BE ACCEPTED.

Interested Parties shall be subject to applicable Navajo Nation Business Opportunity Act requirements. ### Purpose of Form
