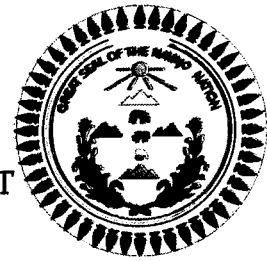

SUBJECT: Tabulated Surplus Vehicle Bids

Attached is the Vehicle Bid List showing results of the qualified bid amount for the surplus vehicles. The bid forms were accepted during our Surplus Vehicle Sale from July 18<sup>th</sup> through July 29<sup>th</sup>. The List is sectioned by vehicle item numbers and sorted according to successor of the bids. The successful winner is listed at the top and next highest bidder, so forth down the list. Pursuant to BFJA-04-20, the successful winner is one with the highest bid amount and who submitted the bid first. The last two columns show the date and time when we received the bid form(s).

We will be calling the successful winners starting this afternoon; although, your name appears as a successor it doesn't mean it's final. We still need to verify if the bid form is filled out completely, accurately, and legibly. Please have your cashier's check or money orders ready and if you are using on payroll deduction to bring in a copy of your latest PAF & full coverage insurance. One of our staff will be contacting the successful bidder throughout this week; thereafter, you have 24 hours to submit your payment to us at Fort Defiance Property Management.

Please eliminate phone calls, if possible, for the staff are busy helping other customers. If you submitted a bid form and your name isn't on the list, any one of the following reasons would have disqualified you: submitted during non-business hours, exceeded the maximum limit, submitted more than two (2) bid forms. You have your receipts to confirm that. Policy information was posted on the website.
