Notice to Dealerships:

A. CONDITIONS GOVERNING THE INVITATION FOR BIDS

Must be authorized and fully certified licensed automotive dealership that meets all the standards and qualification from the vehicle manufacture in terms of facilities, equipment, parts, tools and trained technicians to handle all required services. Vehicle must be delivered in a timely manner as bid evaluation will be based on most responsive bid in accordance to specifications and criteria. Should the Bidder be verified as being on the Navajo Nation Business Regulatory Listing, they will have an advantage. However, this does not guaranteed BID award. BID price shall be F.O.B. Window Rock and to the designated delivery point at Fleet Management Department. Vehicles shall be delivered to the Navajo Nation free from any purchase money or lien or security interest. The manufacturers published warranty for the vehicle shall apply to all vehicles purchased by Navajo Division of Aging and Long Term Care Support.

The Navajo Nation is not bound to enter into a contract under Invitation for Bids and may issue a subsequent Invitation for Bids for the same goods.

Since the Navajo Nation is a Sovereign government all contracts entered shall comply with, all Navajo Nation law, rules and regulations, as well as applicable federal laws, rules and regulations.

B. CONDITIONS GOVERNING THE PROCUREMENT

Bid shall be effective on date of award and the availability of funds will determine the number of vehicle amenities to be purchased, and additional procurement for like kind and quality of vehicles also qualifies for bid price. Navajo Nation Fleet Management personnel will make on-site visits to either manufacturer's/ Bidders facilities, as needed, to ensure compliance with specifications are met, of approve any deviations, if necessary.

The Navajo Nation Fleet Management will receive, at time of delivery of vehicles, all pertinent documents necessary for titling and licensing vehicles, documents include Manufacturer's statement of Origin and Odometer statement. Only Navajo Nation Fleet will be responsible for registering all vehicles through the Navajo Nation Property Management Department.

Payment will be made after delivery of the vehicle and receipt of all pertinent documents, including invoice. Full payment is to be made no Later than 15 days following receipt of all pertinent documents, including invoice. Temporary license sticker must accompany delivery if no release Manufacturer Statement of Origin is included as part of the documents: and will delay timely payment.

C. <u>SPECIFICATIONS</u>
