Replacing of damaged Electrical wiring/ light fixtures, and grouting and underpinning of facility landscape.

• **DESCRIPTION OF THE ORGANIZATION**

The Navajo Nation Department of Corrections - Chinle District is a Detention facility for youth offenders. The facility's plumbing and flooring; tiles & carpet, walls, one area of drop-ceiling has been damaged by the water breakage from a broken pipeline at one of the plumbing chases (closet) in the dayroom of the girls/ boys housing unit and sally port also causing electrical wiring damages and damages to the fixtures. Water breakage caused massive sinkholes in and around landscaping of Chinle Youth Detention Center.

• **SCOPE OF THE CONTRACT**

The Navajo Nation Department of Corrections - Chinle District, intends to enter a professional service contract with the (1) one responsible, qualified and independent building Contractor to provide work as described at Chinle, Arizona.

• **RESPONDENT REQUIREMENTS**

All respondents must have the capabilities listed herein, including sufficient detailed information with regard to experience and expertise in meeting the following requirements:

- A legitimate and credible vendor with a minimum of 5 years' experience and a history with providing building service and installation.
- The Navajo Business Opportunity Act 5 NNC § 201, 205 will apply.
- All workmanship and materials shall comply with applicable Safety Codes.
- A detailed scope of work and drawings of all work.

• **SCOPE OF WORK**

The Navajo Nation Department of Corrections – Chinle District, is seeking a building Contractor that can provide and conduct all of the following services:

- Replace 1 1/2-inch copper pipe and fittings,
- Inspect all existing plumbing chase throughout the building and repair.
- Grouting and Underpinning of the Chinle District – Corrections' facility landscaping.
- Provide warranty service on all applicable products and services.
- Meet a stringent schedule to meet the needs of the Chinle District – Corrections' facility.
- Site Work: The contractor will furnish all equipment, materials and labor that is needed to complete the site work relating to the project.
- Demolition: The Contractor will demolish and dispose of all materials relating to the deconstruction/replacement of the existing fixtures required to complete repairs. Materials will be reuse, recycled or disposed of as applicable.
- Installation: The Contractor will furnish all labor and materials necessary to complete the repair of the copper water pipe(s) and replacement of Owens

Corning Pipe Insulation tube of 1" (thick) X 36" (length), flooring; vinyl composition tiles (12"x12") on 36 square footages, and 24"x 24" carpet tiles on 60 square footage, drywall drop-ceiling, repaint all cinder-block walls on 212 square footages. The floor repairs and repainting the walls will be at four areas in two (2) housing pods; male and female.

- Electrical: The contractor will furnish all labor and materials necessary to complete the electrical work relating to this project, as shown on plans and outlined.
- Clean up: The contractor will be responsible for all construction related clean up and debris disposal. The Contractor will also isolate work areas to minimize impact to non-work-related spaces: however, some dust and debris propagation should be expected.
- Training: The Contractor will provide training to staff on preventive maintenance of plumbing chase and the proper routine of flash-patrol.

- The Navajo Nation Department of Corrections-Chinle District reserves the right to interview respondents if deemed necessary due to tied scores or other legitimate matters. This may entail a presentation from the respondent for clarification and/or details on products or other requirements. The presentation will be scheduled to be presented in Chinle, Arizona (if necessary). It is the CLDOC intention to award one (1) to provide all services as specified.

- **TYPE OF CONTRACT**

The Navajo Nation will utilize a standard Professional Services Contract for the procurement of goods and services for this project.

- **TAX**

All appropriate taxes should be included in cost of services including the Navajo Sales Tax. All work performed in Chinle, Arizona is within the territorial jurisdiction of the Navajo Nation and is subject to the 6% sales tax.

- **TERM**

The Navajo Nation will not relinquish any of its sovereignty rights.

- **COMPLIANCE WITH LAWS AND REGULATIONS**

The successful Vendor shall comply with all Federal, Tribal, State and Local Laws, regulations and Navajo Nation rules and policies pertaining to work under our charge, and shall, at its expense, procure any permits that may be required.

- **PERIOD OF PERFORMANCE**

The period of the performance will be determined and negotiated based on the scheduled proposed by the respondent and the contract implementation date.

NAVAJO NATION CERTIFICATION Regarding Debarment, Suspension, and Contracting Eligibility

1. Applicant entity acknowledges that to the best of its knowledge that the Applicant entity, either in its present form or in any identifiable capacity, has not, in accordance with 12 N.N.C. § 361:
 - A. Been convicted of the commission of criminal offenses incident to obtaining or attempting to obtain a public or private contract or subcontract, or in the performance of any such contract or subcontract;
 - B. Been convicted of embezzlement, theft, forgery, bribery, falsification or destruction of records, receiving stolen property, or other offenses indicating a lack of business integrity or honesty, which currently, seriously, and directly affect responsibility as a Navajo Nation contractor;
 - C. Been convicted under antitrust statutes arising out of the submission of bids or proposals;
 - D. Violated contract provisions, including:
 - i. Deliberate failure, without good cause, to perform in accordance with the contract specifications or within the time limit provided in the contract,
 - ii. A recent record of failure to perform or of unsatisfactory performance with the terms of any contract, or
 - iii. Any other cause so serious and compelling as to affect responsibility as a Navajo Nation contractor, including debarment by another governmental entity.
2. Applicant acknowledges that if the Navajo Nation determines that the executed Certification provided herein is untrue or not wholly accurate, it shall be grounds for the Navajo Nation to terminate the contract and pursue other legal remedies, at the Navajo Nation's discretion.
3. Applicant certifies to the best of its knowledge that it is eligible to do business with the

Navajo Nation, in its present form or in any other identifiable capacity, pursuant to 12 N.N.C. § 1501 and 5 N.N.C. § 301. Applicant also acknowledges that per 12 N.N.C. § 1505, it will not be eligible to contract with the Navajo Nation if deemed ineligible by the appropriate department or entity of the Navajo Nation which receives the Applicant's request for consideration for a business opportunity.
