# Request for Proposal (RFP) for Third-Party Monitoring and Reporting Services

#### 1. Introduction:

The Navajo Nation Fiscal Recovery Fund Office (NNFRFO), is responsible for, overseeing the distribution of Fiscal Recovery Funds allocated under the American Rescue Plan Act (ARPA) of 2021 to the Navajo Nation. NNFRFO is responsible for ensuring compliance with Federal, Navajo Nation laws and regulations governing the use of Fiscal Recovery Funds.

## 2. Objectives:

The objective of this Request for Proposals (RFP) is to solicit comprehensive proposals from qualified vendors to provide third-party monitoring of Fiscal Recovery Funds and reporting of the use of those Funds. The selected vendor will be tasked with executing, monitoring, and reporting duties in a thorough and professional manner, contributing to the transparent and accountable management of Funds.

# 3. Scope of Work:

The selected vendor will be responsible for:

- a. Designing a robust monitoring and reporting framework in alignment with the responsibilities and functions of the Navajo Nation Fiscal Recovery Fund (NNFRF) Office.
- b. Ensuring compliance with the provisions of the American Rescue Plan Act (ARPA) and Navajo Nation laws and regulations by all receiving Funds.
- c. Detailed monitoring of the completion of authorized projects and services in accordance with approved eligibility determinations.
- d. Assisting and supporting the Navajo Nation Fiscal Recovery Fund Office and its affiliated Navajo Nation Departments in monitoring the expenditure of NNFRFO funds and submitting timely and accurate ARPA reports to the Navajo Nation Government and the Federal Government.

# 4. Qualifications and Experience:

Interested vendors should demonstrate the following qualifications and experience:

- a. Proven track record of successfully providing third-party monitoring and reporting services for projects involving compliance with federal regulations.
- b. Expertise in designing monitoring frameworks that align with specific program requirements and responsibilities, including those outlined for the Navajo Nation Fiscal Recovery Fund (NNFRF) Office.
- c. Strong understanding of the American Rescue Plan Act (ARPA), Fiscal Recovery Funds guidelines, experience in ensuring compliance with relevant laws and regulations.
- d. Demonstrated ability to facilitate the expenditure of funds in a timely and efficient manner while adhering to approved guidelines.
- e. Experience in supporting financial monitoring activities and preparing accurate reports for submission to government entities.

#### 5. Proposal Submission:

Interested vendors are required to submit comprehensive proposals by May 28, 2024, to Lisa Jymm (Executive Director NNFRFO). Proposals should include:

- a. Packets must be hand carried or certified mail only, packet submissions must then be enclosed inside of sealed package. (NO EMAIL SUBMISSION)
- b. Enclosed packet must be clearly marked PRIORTY ONE, TWO, THREE on the outside of the enclosed packet.
- c. 5 Complete Copies of RFP with 1 Original
- d. Cover Letter (1 Page) Signed by the President/CEO/Partnerships
- e. Below Items will be 20 Pages (can be double sided, count as 1 page)
- f. Qualifications to meet scope of work and capacity of the undertaking. This shall include any licenses, the size of the business, office location from which the services are provided.
- g. Detailed company profile highlighting relevant experience and expertise.
- h. Proposed methodology and approach to monitoring and reporting.
- i. Work plan outlining tasks, timelines, and deliverables.
- j. Budget proposal with a breakdown of costs and fees.
- k. Team composition and roles/responsibilities of key personnel, and equipment available.
- 1. Case studies or references from past monitoring and reporting projects.

#### 6. Evaluation Criteria:

Proposals will be evaluated based on the following criteria:

- a. Relevance and depth of experience in providing monitoring and reporting services.
- b. Clarity and effectiveness of the proposed methodology and approach.
- c. Cost-effectiveness and value for money.
- d. Demonstrated ability to meet project timelines and deliver high-quality outputs.
- e. References and testimonials from previous clients.

# 8. Requirement of the Firm if Contract Awarded:

- a. Comply with all applicable Federal Compliance and Reporting Requirements-State and Local Fiscal Recovery Funds, March 28,2024, Version 6.0 (as amended)
- b. The selected firm shall comply with all Navajo Nation Divisions of Finance procedures and guidelines whenever services are delivered or accepted.
- c. The selected firm shall comply with all provisions of the Navajo Preference in Employment Act at 15 NNC. § 601 et seq. and NBOA (5NNC § 201 et seq)
- d. The selected firm shall contact the Navajo Nations's Source List of firms to be given priority in Firms' selection of Subcontractors for this project. <u>Firms already working on Navajo Nation</u> *ARPA projects will not be considered*.

# 9. Scoring of RFP

Evaluation Criteria for RFP Submission Scoring (Total: 100 Points):

Experience in Monitoring and Reporting Services (20 Points):

- Assessment of the depth and breadth of prior experience in providing monitoring and reporting services.
- b. Evaluation of the quality and success of past projects in this area.
- c. Consideration of any relevant certifications or industry recognitions related to monitoring and reporting services.

Qualifications to Fulfill Scope of Work and Capacity Requirements, Including State Licenses and Certifications (20 Points):

- a. Review of qualifications, including educational background, professional certifications, and relevant training.
- b. Assessment of the capacity to meet the specific requirements outlined in the RFP.
- c. Verification of state licenses and certifications necessary to carry out the proposed work.

Proposal Quality, Including Clarity, Organization, Relevant Experience, and the Inclusion of an Effective Cover Letter (20 Points):

- a. Examination of the overall quality and coherence of the proposal document.
- b. Assessment of the clarity and organization of the proposed approach to the project.
- c. Review of the relevance of previous experience to the current scope of work.
- d. Evaluation of the effectiveness of the cover letter in conveying key points and demonstrating understanding of the project requirements.

Past experiences collaborating with Navajo Nation Government Departments, Entities, and Chapters on Projects (20 Points):

- a. Analysis of past collaborations with various Navajo Nation Government entities.
- b. Evaluation of the success and impact of previous projects involving Navajo Nation stakeholders.
- c. Consideration of the ability to effectively engage and work with diverse government departments and entities within the Navajo Nation.

Ability to Manage Large-Scale Projects, Including Monitoring and Reporting Services, and Demonstration of Sufficient Manpower Capabilities (10 Points):

- a. Assessment of the capacity to handle complex and large-scale projects effectively.
- b. Evaluation of the ability to manage monitoring and reporting services in the context of a significant project.
- c. Review of available manpower resources and their adequacy for the proposed project scope.

Familiarity with Navajo Nation geography and the skillfulness to navigate the area effectively (10 **Points**):

- a. Consideration of the knowledge and understanding of the unique geographical features of the Navajo Nation.
- b. Evaluation of the ability to navigate and work within the specific geographic context of the Navajo Nation effectively.
- c. Assessment of any relevant experience or training related to working in this geographic area.

#### 10. Terms and Conditions

- a. Nothing in this Request for Proposal (RFP) is intended to, nor shall it have the effect of waiving any privileges or immunities afforded to The Navajo Nation, including but not limited to sovereign immunity or official immunity. It is expressly agreed that The Navajo Nation retains such privileges, ensuring the protection of its legal rights and status.
- b. The Navajo Nation, as a sovereign government entity, requires that all contracts resulting from this RFP fully comply with Navajo Nation Law, Rules, and Regulations. This includes adherence to the Navajo Preference in Employment Act and relevant federal laws, rules, and regulations. Contractors are expected to operate within the legal framework established by the Navajo Nation, demonstrating respect for its sovereignty and commitment to upholding local and federal compliance standards. Employment Act and applicable federal laws, rules, and regulations.



# What's New

Line 3a has been modified to clarify how a disregarded entity completes this line. An LLC that is a disregarded entity should check the appropriate box for the tax classification of its owner. Otherwise, it should check the "LLC" box and enter its appropriate tax classification.

New line 3b has been added to this form. A flow-through entity is required to complete this line to indicate that it has direct or indirect foreign partners, owners, or beneficiaries when it provides the Form W-9 to another flow-through entity in which it has an ownership interest. This change is intended to provide a flow-through entity with information regarding the status of its indirect foreign partners, owners, or beneficiaries, so that it can satisfy any applicable reporting requirements. For example, a partnership that has any indirect foreign partners may be required to complete Schedules K-2 and K-3. See the Partnership Instructions for Schedules K-2 and K-3 (Form 1065).

#### **Purpose of Form**

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS is giving you this form because they

must obtain your correct taxpayer identification number (TIN), which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

- Form 1099-INT (interest earned or paid).
- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds).
- Form 1099-NEC (nonemployee compensation).
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers).
- Form 1099-S (proceeds from real estate transactions).
- Form 1099-K (merchant card and third-party network transactions).
- Form 1098 (home mortgage interest), 1098-E (student loan interest), and 1098-T (tuition).
- Form 1099-C (canceled debt).
- Form 1099-A (acquisition or abandonment of secured property).

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.

Caution: If you don't return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See What is backup withholding, later.

#### By signing the filled-out form, you:

- Certify that the TIN you are giving is correct (or you are waiting for a number to be issued);
  - 2. Certify that you are not subject to backup withholding; or
- 3. Claim exemption from backup withholding if you are a U.S. exempt pavee: and
- 4. Certify to your non-foreign status for purposes of withholding under chapter 3 or 4 of the Code (if applicable); and
- 5. Certify that FATCA code(s) entered on this form (if any) indicating that you are exempt from the FATCA reporting is correct. See *What Is FATCA Reporting*, later, for further information.

Note: If you are a U.S. person and a requester gives you a form other than Form W-9 to request your TIN, you must use the requester's form if it is substantially similar to this Form W-9.

**Definition of a U.S. person.** For federal tax purposes, you are considered a U.S. person if you are:

- An individual who is a U.S. citizen or U.S. resident alien;
- A partnership, corporation, company, or association created or organized in the United States or under the laws of the United States;
- . An estate (other than a foreign estate); or
- A domestic trust (as defined in Regulations section 301.7701-7).

Establishing U.S. status for purposes of chapter 3 and chapter 4 withholding. Payments made to foreign persons, including certain distributions, allocations of income, or transfers of sales proceeds, may be subject to withholding under chapter 3 or chapter 4 of the Code (sections 1441–1474). Under those rules, if a Form W-9 or other certification of non-foreign status has not been received, a withholding agent, transferee, or partnership (payor) generally applies presumption rules that may require the payor to withhold applicable tax from the recipient, owner, transferor, or partner (payee). See Pub. 515, Withholding of Tax on Nonresident Aliens and Foreign Entities.

The following persons must provide Form W-9 to the payor for purposes of establishing its non-foreign status.

- In the case of a disregarded entity with a U.S. owner, the U.S. owner of the disregarded entity and not the disregarded entity.
- In the case of a grantor trust with a U.S. grantor or other U.S. owner, generally, the U.S. grantor or other U.S. owner of the grantor trust and not the grantor trust.
- In the case of a U.S. trust (other than a grantor trust), the U.S. trust and not the beneficiaries of the trust.

See Pub. 515 for more information on providing a Form W-9 or a certification of non-foreign status to avoid withholding.

Foreign person. If you are a foreign person or the U.S. branch of a foreign bank that has elected to be treated as a U.S. person (under Regulations section 1.1441-1(b)(2)(iv) or other applicable section for chapter 3 or 4 purposes), do not use Form W-9. Instead, use the appropriate Form W-8 or Form 8233 (see Pub. 515). If you are a qualified foreign pension fund under Regulations section 1.897(i)-1(d), or a partnership that is wholly owned by qualified foreign pension funds, that is treated as a non-foreign person for purposes of section 1445 withholding, do not use Form W-9. Instead, use Form W-8EXP (or other certification of non-foreign status).

Nonresident alien who becomes a resident alien. Generally, only a nonresident alien individual may use the terms of a tax treaty to reduce or eliminate U.S. tax on certain types of income. However, most tax treaties contain a provision known as a saving clause. Exceptions specified in the saving clause may permit an exemption from tax to continue for certain types of income even after the payee has otherwise become a U.S. resident alien for tax purposes.

If you are a U.S. resident alien who is relying on an exception contained in the saving clause of a tax treaty to claim an exemption from U.S. tax on certain types of income, you must attach a statement to Form W-9 that specifies the following five items.

- 1. The treaty country. Generally, this must be the same treaty under which you claimed exemption from tax as a nonresident alien.
  - 2. The treaty article addressing the income.
- 3. The article number (or location) in the tax treaty that contains the saving clause and its exceptions.
- 4. The type and amount of income that qualifies for the exemption from tax.
- 5. Sufficient facts to justify the exemption from tax under the terms of the treaty article.

Example. Article 20 of the U.S.-China income tax treaty allows an exemption from tax for scholarship income received by a Chinese student temporarily present in the United States. Under U.S. law, this student will become a resident alien for tax purposes if their stay in the United States exceeds 5 calendar years. However, paragraph 2 of the first Protocol to the U.S.-China treaty (dated April 30, 1984) allows the provisions of Article 20 to continue to apply even after the Chinese student becomes a resident alien of the United States. A Chinese student who qualifies for this exception (under paragraph 2 of the first Protocol) and is relying on this exception to claim an exemption from tax on their scholarship or fellowship income would attach to Form W-9 a statement that includes the information described above to support that exemption.

If you are a nonresident alien or a foreign entity, give the requester the appropriate completed Form W-8 or Form 8233.

#### **Backup Withholding**

What is backup withholding? Persons making certain payments to you must under certain conditions withhold and pay to the IRS 24% of such payments. This is called "backup withholding." Payments that may be subject to backup withholding include, but are not limited to, interest, tax-exempt interest, dividends, broker and barter exchange transactions, rents, royalties, nonemployee pay, payments made in settlement of payment card and third-party network transactions, and certain payments from fishing boat operators. Real estate transactions are not subject to backup withholding.

You will not be subject to backup withholding on payments you receive if you give the requester your correct TIN, make the proper certifications, and report all your taxable interest and dividends on your tax return.

#### Payments you receive will be subject to backup withholding if:

- 1. You do not furnish your TIN to the requester;
- 2. You do not certify your TIN when required (see the instructions for Part II for details);
  - 3. The IRS tells the requester that you furnished an incorrect TIN;
- 4. The IRS tells you that you are subject to backup withholding because you did not report all your interest and dividends on your tax return (for reportable interest and dividends only); or
- 5. You do not certify to the requester that you are not subject to backup withholding, as described in item 4 under "By signing the filled-out form" above (for reportable interest and dividend accounts opened after 1983 only).

Certain payees and payments are exempt from backup withholding. See *Exempt payee code*, later, and the separate Instructions for the Requester of Form W-9 for more information.

See also Establishing U.S. status for purposes of chapter 3 and chapter 4 withholding, earlier.

# What Is FATCA Reporting?

The Foreign Account Tax Compliance Act (FATCA) requires a participating foreign financial institution to report all U.S. account holders that are specified U.S. persons. Certain payees are exempt from FATCA reporting. See Exemption from FATCA reporting code, later, and the Instructions for the Requester of Form W-9 for more information.

# **Updating Your Information**

You must provide updated information to any person to whom you claimed to be an exempt payee if you are no longer an exempt payee and anticipate receiving reportable payments in the future from this person. For example, you may need to provide updated information if you are a C corporation that elects to be an S corporation, or if you are no longer tax exempt. In addition, you must furnish a new Form W-9 if the name or TIN changes for the account, for example, if the grantor of a grantor trust dies.

#### **Penalties**

Failure to furnish TIN. If you fail to furnish your correct TIN to a requester, you are subject to a penalty of \$50 for each such failure unless your failure is due to reasonable cause and not to willful neglect.

Civil penalty for false information with respect to withholding. If you make a false statement with no reasonable basis that results in no backup withholding, you are subject to a \$500 penalty.

Criminal penalty for falsifying information. Willfully falsifying certifications or affirmations may subject you to criminal penalties including fines and/or imprisonment.

Misuse of TINs. If the requester discloses or uses TINs in violation of federal law, the requester may be subject to civil and criminal penalties.

# **Specific Instructions**

#### Line 1

You must enter one of the following on this line; do not leave this line blank. The name should match the name on your tax return.

If this Form W-9 is for a joint account (other than an account maintained by a foreign financial institution (FFI)), list first, and then circle, the name of the person or entity whose number you entered in Part I of Form W-9. If you are providing Form W-9 to an FFI to document a joint account, each holder of the account that is a U.S. person must provide a Form W-9.

• Individual. Generally, enter the name shown on your tax return. If you have changed your last name without informing the Social Security Administration (SSA) of the name change, enter your first name, the last name as shown on your social security card, and your new last name.

Note for ITIN applicant: Enter your individual name as it was entered on your Form W-7 application, line 1a. This should also be the same as the name you entered on the Form 1040 you filed with your application.

- Sole proprietor. Enter your individual name as shown on your Form 1040 on line 1. Enter your business, trade, or "doing business as" (DBA) name on line 2.
- Partnership, C corporation, S corporation, or LLC, other than a disregarded entity. Enter the entity's name as shown on the entity's tax return on line 1 and any business, trade, or DBA name on line 2.
- Other entities. Enter your name as shown on required U.S. federal tax documents on line 1. This name should match the name shown on the charter or other legal document creating the entity. Enter any business, trade, or DBA name on line 2.
- Disregarded entity. In general, a business entity that has a single owner, including an LLC, and is not a corporation, is disregarded as an entity separate from its owner (a disregarded entity). See Regulations section 301.7701-2(c)(2). A disregarded entity should check the appropriate box for the tax classification of its owner. Enter the owner's name on line 1. The name of the owner entered on line 1 should never be a disregarded entity. The name on line 1 should be the name shown on the income tax return on which the income should be reported. For

example, if a foreign LLC that is treated as a disregarded entity for U.S. federal tax purposes has a single owner that is a U.S. person, the U.S. owner's name is required to be provided on line 1. If the direct owner of the entity is also a disregarded entity, enter the first owner that is not disregarded for federal tax purposes. Enter the disregarded entity's name on line 2. If the owner of the disregarded entity is a foreign person, the owner must complete an appropriate Form W-8 instead of a Form W-9. This is the case even if the foreign person has a U.S. TIN.

#### l ina 9

If you have a business name, trade name, DBA name, or disregarded entity name, enter it on line 2.

#### Line 3a

#### Line 3b

Check this box if you are a partnership (including an LLC classified as a partnership for U.S. federal tax purposes), trust, or estate that has any foreign partners, owners, or beneficiaries, and you are providing this form to a partnership, trust, or estate, in which you have an ownership interest. You must check the box on line 3b if you receive a Form W-8 (or documentary evidence) from any partner, owner, or beneficiary establishing foreign status or if you receive a Form W-9 from any partner, owner, or beneficiary that has checked the box on line 3b.

**Note:** A partnership that provides a Form W-9 and checks box 3b may be required to complete Schedules K-2 and K-3 (Form 1065). For more information, see the Partnership Instructions for Schedules K-2 and K-3 (Form 1065).

If you are required to complete line 3b but fail to do so, you may not receive the information necessary to file a correct information return with the IRS or furnish a correct payee statement to your partners or beneficiaries. See, for example, sections 6698, 6722, and 6724 for penalties that may apply.

#### **Line 4 Exemptions**

If you are exempt from backup withholding and/or FATCA reporting, enter in the appropriate space on line 4 any code(s) that may apply to you.

#### Exempt payee code.

- Generally, individuals (including sole proprietors) are not exempt from backup withholding.
- Except as provided below, corporations are exempt from backup withholding for certain payments, including interest and dividends.
- Corporations are not exempt from backup withholding for payments made in settlement of payment card or third-party network transactions.
- Corporations are not exempt from backup withholding with respect to attorneys' fees or gross proceeds paid to attorneys, and corporations that provide medical or health care services are not exempt with respect to payments reportable on Form 1099-MISC.

- 1. Applicant entity acknowledges that to the best of its knowledge that the Applicant entity, either in its present form or in any identifiable capacity, has not, in accordance with 12 N.N.C. § 361:
  - A. Been convicted of the commission of criminal offenses incident to obtaining or attempting to obtain a public or private contract or subcontract, or in the performance of any such contract or subcontract;
  - B. Been convicted of embezzlement, theft, forgery, bribery, falsification or destruction of records, receiving stolen property, or other offenses indicating a lack of business integrity or honesty, which currently, seriously, and directly affect responsibility as a Navajo Nation contractor;
  - C. Been convicted under antitrust statutes arising out of the submission of bids or proposals;
  - D. Violated contract provisions, including:
    - Deliberate failure, without good cause, to perform in accordance with i. the contract specifications or within the time limit provided in the contract.
    - ii. A recent record of failure to perform or of unsatisfactory performance with the terms of any contract, or
    - Any other cause so serious and compelling as to affect responsibility iii. as a Navajo Nation contractor, including debarment by another governmental entity.
- 2. Applicant acknowledges that if the Navajo Nation determines that the executed Certification provided herein is untrue or not wholly accurate, it shall be grounds for the Navajo Nation to terminate the contract and pursue other legal remedies, at the Navajo Nation's discretion.
- 3. Applicant certifies to the best of its knowledge that it is eligible to do business with the

Navajo Nation, in its present form or in any other identifiable capacity, pursuant to 12 N.N.C. § 1501 and 5 N.N.C. § 301. Applicant also acknowledges that per 12 N.N.C. § 1505, it will not be eligible to contract with the Navajo Nation if deemed ineligible by the appropriate department or entity of the Navajo Nation which receives the Applicant's request for consideration for a business opportunity.
