INSTRUCTIONS TO BIDDERS AND GENERAL INFORMATION

PROJECT BACKGROUND

Shiprock Irrigation Office currently has an unpaved access road and designated area for parking that services the Farmers and community members.

- 1. Access road is not paved and is not maintained by the local Chapter, the State or the BIA.
- 2. Shiprock Irrigation Department needs resurfacing and paving of all areas including entry way, parking, loading and unloading zones.
- 3. The problematic area is the entry way into Shiprock Irrigation Office when it rains or snows. The road becomes very muddy and slick and at times not passable.
- 4. Current parking areas are unidentified along with the loading and unloading areas.

SCOPE OF WORK

Final Design

- 1. Complete a final design for paving Access Road, Office Parking Lot and Warehouse Parking Lot. The design will include proper drainage, safety features such as striping for parking spaces, handicap parking and loading/unloading zones. The final design will involve 30%, 60%, and 90% reviews, specifications and a stamped final design by a licensed Professional Engineer in the State of New Mexico.
- 2. Identified areas requiring paving is attached.
- 3. Contractor will be responsible for assessing the identified areas and completing the final design.
- 4. Perform project and budget management for the duration of the project including surveying and any required testing.

All materials must be new and Made in the USA. A 2-year limited warranty is required on all materials. The Contractor is responsible for all labor, materials, equipment and freight.

The Navajo Nation is not responsible for any "Down Time" including late delivery of materials, any act of negligence on the part of the supplier and any unforeseen occurrence. These are not billable to the Navajo Nation and will not be considered for payment.

DELIVERABLES

The Contractor shall provide the Owner with electronic and hard copies of the final design report. The final design report shall incorporate the comments from the 90% design review and include:

- 1. Final design drawings and specifications with Professional Engineer stamp.
- 2. Final project construction schedule.
- 3. Safety Plan, Temporary Traffic Control Plan, Storm Water Pollution Prevention Plan, Quality Control Plan.
- 4. Final As-Built Drawings

The NNDWR reserves the right to reject any or all bids or to accept any bid that in its judgment will be in the best interest of the general public. It is the intention to award contract to the bidder best meeting the requirements.

PREFERENCE OF NAVAJO AND INDIAN-OWNED BUSINESSES

Preference of Navajo and Indian-owned businesses will be given under the Navajo Nation Business Opportunity Act, 5 NNC §201 et. seq., and the Navajo Nation Procurement Act, 12 NNC §303. Evaluation points will be awarded to Navajo and minority respondents. Certification of Navajo Owned Business will be assured by certificate held by the Navajo Nation Business Regulatory Department.

NAVAJO NATION SALES TAXES

All work performed within the territorial jurisdiction of the Navajo Nation is subject to the six percent (6%) Navajo Sales TAX. 24 N.N.C. § 601 et. seq. The Navajo Nation shall withhold from each payment to the "CONTRACTOR" 6% of the total invoice amount associated with work performed within the Navajo Nation. This amount reflects the Navajo Sales Tax due on such invoice amount. This 6% shall be transferred to the Office of the Navajo Tax Commission as a payment of the tax on behalf of the "CONTRACTOR".
