INVITATION: Hogback Irrigation Diversion Water Pump Replacement

The Navajo Nation Department of Fish and Wildlife is requesting proposals from qualified contractors to purchase and replace the water pump at the Hogback Irrigation Diversion on the San Juan River.

Work to be performed includes:

1. Purchase and install a new 40 hp pump (3,584 gpm, 1,750 rpm, 460v/60Hz) with new intakes and a soft-start (see Appendix A) that are compatible with the fish monitoring equipment.
2. Purchase and install a new 150 hp pump (4,480 gpm, 1750 rpm/460v/60Hz) with new intakes and a soft-start (see Appendix A) that are compatible with the fish monitoring equipment.
3. Modify discharge manifold piping to accommodate new pumps
4. Rebuild the existing 300 hp pump and retrofit with a soft-start. This includes transport of the pump to the repair facility and return to Shiprock Irrigation District Warehouse.
5. Modify the electric supply to the new pumps per electrical code

The design and drawings for the electrical system upgrade of the Hogback Pump Station will be provided. The work to be performed as part of the electrical upgrades includes:

50 HP Section

1. Disconnect and remove existing VFD and cabinet
2. Trench and install new conduit run from the starter to the proposed motor pad location on the west side of the existing structure
3. Add an additional conduit to the existing 50 hp motor
4. Install the new soft-start and enclosure to the back side of the Unistrut structure. Extend the existing conduit from the existing location to the new drive location
5. Install new 3-way disconnect (ON-OFF-ON) in the location of the existing 50 hp drive
6. Install new conduit from the 3-way to the drive and field devices
7. Install new conductors to the proposed 50 hp concrete pad
8. Add a liquid-tight conduit for the new 50 hp motor

9. Replace the liquid-tight conduit and connectors for existing 50 hp motor
- 150 HP Section**
10. Disconnect and remove existing VFD and cabinet
11. Install the new soft-start and enclosure to the back side of the Unistrut structure.
Extend the existing conduit from the existing location to the new drive location
12. Install new 3-way disconnect (ON-OFF-ON) in the location of the existing 150 hp drive
13. Install new conduit from the 3-way to the drive and field devices

Figure 2. is an engineering drawing of the Hogback Pump plant location and facility. Additional drawings included High and Low Lift Unit Notes and Dimensions, Bolted flange Support Concept, New 14" Diameter Discharge Piping. 6 " Diameter Outlet -High-Lift Unit Piping and existing water line.

The Navajo Nation is a sovereign government and all contracts entered into as a result of this RFP shall comply with Navajo Nation Law, rules and regulations, including the Navajo Preference in Employment Act, and applicable federal; laws, rules and regulations.

The payment procedures established by the Division of Finance shall be adhered to and are to begin whenever goods are delivered and accepted.

Must have experience with designing and building boat ramps in riverine systems.

Navajo Preference applies but does not guarantee Bid Award.

Offeror must provide qualifications and experience to design and build a boat ramp in a riverine environment.

The Navajo Nation is not bound to enter into a contract under this RFP and may issue a subsequent RFP for the same purchase. Since the Navajo Nation is a sovereign government, all contracts entered shall comply with Navajo Nation Law, rules and regulations, as well as federal laws, rules and regulations.

CONDITIONS GOVERNING THE PROCUREMENT :

Bid shall be effective on the date of award.

INSTRUCTIONS TO OFFERORS:

Must Identify Bid # and Company name on the outside of al sealed package/envelopes.

Submit an original and two (2) copies of sealed bid.

Visibly mark on the outside of the proposal package, if applicable, the offeror's priority status under the Navajo Nation Business Opportunity Act.

It is the respohsibility of the offeror to identify themselves as certified under the Navajo Nation Business Opportunity Act.

The Bids will open on June 3, 2024 and close on June 14, 2024 at 5 pm MDT. RFP's received after the specified time will not be accepted. Please allow adequate time for delivery. NAVAJO NATION CERTIFICATION
Regarding Debarment, Suspension, and
Contracting Eligibility

1. Applicant entity acknowledges that to the best of its knowledge that the Applicant entity, either in its present form or in any identifiable capacity, has not, in accordance with 12 N.N.C. § 361:
 - A. Been convicted of the commission of criminal offenses incident to obtaining or attempting to obtain a public or private contract or subcontract, or in the performance of any such contract or subcontract;
 - B. Been convicted of embezzlement, theft, forgery, bribery, falsification or destruction of records, receiving stolen property, or other offenses indicating a lack of business integrity or honesty, which currently, seriously, and directly affect responsibility as a Navajo Nation contractor;
 - C. Been convicted under antitrust statutes arising out of the submission of bids or proposals;
 - D. Violated contract provisions, including:
 - i. Deliberate failure, without good cause, to perform in accordance with the contract specifications or within the time limit provided in the contract,
 - ii. A recent record of failure to perform or of unsatisfactory performance with the terms of any contract, or
 - iii. Any other cause so serious and compelling as to affect responsibility as a Navajo Nation contractor, including debarment by another governmental entity.
2. Applicant acknowledges that if the Navajo Nation determines that the executed Certification provided herein is untrue or not wholly accurate, it shall be grounds for the Navajo Nation to terminate the contract and pursue other legal remedies, at the Navajo Nation's discretion.
3. Applicant certifies to the best of its knowledge that it is eligible to do business with the

Navajo Nation, in its present form or in any other identifiable capacity, pursuant to 12 N.N.C. § 1501 and 5 N.N.C. § 301. Applicant also acknowledges that per 12 N.N.C. § 1505, it will not be eligible to contract with the Navajo Nation if deemed ineligible by the appropriate department or entity of the Navajo Nation which receives the Applicant's request for consideration for a business opportunity.
