Notice to VENDORS:

A. CONDITIONS GOVERNING THE INVITATION FOR BIDS

Vendors must be authorized and fully-certified, pet product and aquarium supply vendors that meets all the standards and qualification to provide products needed by Navajo Nation Zoo. Purchased items must be delivered to Window Rock AZ. Or vendor must be within 1 hour drive of Window Rock for pick up by Navajo Zoo Personnel. Vendor must be able to provide most (at least $\frac{3}{4}$) of the items needed by the Navajo Zoo, as described in Specifications below, for convenient large purchases with one vendor.

The Navajo Nation is not bound to enter into a contract under Invitation for Bids and may issue a subsequent Invitation for Bids for the same goods.

Since the Navajo Nation is a Sovereign government all contracts entered shall comply with, all Navajo Nation law, rules and regulations, as well as applicable federal laws, rules and regulations.

B. CONDITIONS GOVERNING THE PROCUREMENT

Bid shall be effective on date of award and the availability of funds, and current needs, will determine the number of items purchase this fiscal year. There may be no exceptions/substitutions to several types of items required for purchase, as indicated below. Navajo Nation Zoo personnel will examine contents of shipments to ensure compliance with specifications.

The Navajo Nation Zoo will receive, at or before time of delivery, all pertinent documents for the fulfilling of orders, and for the payment process.

Payment will be made after delivery or receipt of the product and receipt of all pertinent documents, including invoice. Full payment is to be made no later than 15 days following receipt of all pertinent documents, including invoice.

C. SPECIFICATIONS

Vendors shall be able to provide the following types of products for sale under purchase order(s) during the fiscal year. Items include: 1) dog/cat feeding bowls, electric water bowls, interactive pet bowls, interactive devices for mammal and avian animals, animal carriers of all sizes, animal treats and dental treatments, basic veterinary products for lizards, turtles, avians, mammals, specialty animal foods for reptiles and amphibians, heat lamps, animal bedding materials, enclosure cleaning supplies, aquarium water treatment and balancing chemicals, fish medical supplies, aquarium supplies, fish foods, live animals of fish, reptiles, amphibians, and invertebrates. D. CLOSING REMARKS

The BIDs will Open on February 3, 2022, and close by February 24, 2023 at 5 p.m. Mountain Standard time. RFP's received after the specified time, will not be accepted. Please all adequate time for delivery. If using a courier service, the vendor is responsible for ensuring the delivery will be made directly to the required location. Please include any applicable fees an 6% Navajo Nation Tax (The Navajo Nation does not pay federal or state taxes)

Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

NAVAJO NATION CERTIFICATION
Regarding Debarment, Suspension, and
Contracting Eligibility

1. Applicant entity acknowledges that to the best of its knowledge that the Applicant entity, either in its present form or in any identifiable capacity, has not, in accordance with 12 N.N.C. § 361:
 - A. Been convicted of the commission of criminal offenses incident to obtaining or attempting to obtain a public or private contract or subcontract, or in the performance of any such contract or subcontract;
 - B. Been convicted of embezzlement, theft, forgery, bribery, falsification or destruction of records, receiving stolen property, or other offenses indicating a lack of business integrity or honesty, which currently, seriously, and directly affect responsibility as a Navajo Nation contractor;
 - C. Been convicted under antitrust statutes arising out of the submission of bids or proposals;
 - D. Violated contract provisions, including:
 - i. Deliberate failure, without good cause, to perform in accordance with the contract specifications or within the time limit provided in the contract,
 - ii. A recent record of failure to perform or of unsatisfactory performance with the terms of any contract, or
 - iii. Any other cause so serious and compelling as to affect responsibility as a Navajo Nation contractor, including debarment by another governmental entity.
2. Applicant acknowledges that if the Navajo Nation determines that the executed Certification provided herein is untrue or not wholly accurate, it shall be grounds for the Navajo Nation to terminate the contract and pursue other legal remedies, at the Navajo Nation's discretion.
3. Applicant certifies to the best of its knowledge that it is eligible to do business with the

Navajo Nation, in its present form or in any other identifiable capacity, pursuant to 12 N.N.C. § 1501 and 5 N.N.C. § 301. Applicant also acknowledges that per 12 N.N.C. § 1505, it will not be eligible to contract with the Navajo Nation if deemed ineligible by the appropriate department or entity of the Navajo Nation which receives the Applicant's request for consideration for a business opportunity.
