## SURPLUS VEHICLE SALE - Crownpoint, NM

The Navajo Nation Property Management announces the Surplus Vehicle Sale at the Property Management yard in Crownpoint. We have about 60 vehicles remaining from our July 2024 sale, operating and non-operating, see attached list. The sale event schedule is as follows:

Vehicle Inspection: March 11<sup>th</sup> -15<sup>th</sup> Tuesday - Saturday 10:00 AM - 3:30 PM March 17<sup>th</sup> - 22<sup>nd</sup> Monday - Saturday 10:00 AM - 3:30 PM

On-site Bid Acceptance: March 24<sup>th</sup> - 29<sup>th</sup> Monday - Saturday
Online Bid Acceptance: March 25<sup>th</sup> - 29<sup>th</sup> Tuesday - Saturday
10:00 AM - 3:30 PM
10:00 AM - 3:30 PM

You will notice the "Online" bidding is scheduled a day later than the On-site (in-person). This is due to limited resources at Crownpoint. We usually get a crowd on the first day of bidding and the line of people doesn't get the true clock-in time for their bids. The bids will still be tabulated as a First-come, First-serve method.

### Important information

All Navajo tribal members with census numbers over 18 years old are eligible to bid. Each customer is allowed to bid on two vehicles at the most. The bidding process will go according to the above schedule. Bids will be accepted only during the dates and times specified above, not a second before or after. To test email, the address is propertyment ooc@nnooc.org, write "Testing for bid process" before the 03/25 and one of our staff will reply to confirm the receipt.

The collected bids will be open at the end of each day to tabulate the number of bids collected per vehicle. When we receive two bids or more at the maximum bid amount, bids for that vehicle will be closed and taken off the daily list. Due to this, the vehicle of your interest may not be available when placing your bid. The successful bidder of the closed bid vehicles will be informed within the next 24 hours. The remaining bids will be tabulated after the closing of the sale event. On Monday, 3/31, the list of bids will be posted.

The vehicles are sold in "AS IS" condition, no guarantees or warranties with all sales are final. A Condition Report is posted on each vehicle window, written when it was declared a surplus. It is strongly recommended you inspect the vehicle of interest before placing a bid. No inspection will be allowed after 03/22/25 due to understaffing.
